Sanctioned strength of Agricultural Assistants in the Department of Agriculture is 3125. The existing ratio between Agricultural Assistant Grade II, Agricultural Assistant Grade-I and Assistant Agricultural Officer in the department is 5:3:2 respectively. As such the sanctioned strength of Agricultural Assistant Grade-I in the department is 937 (312/x 3)

As per order read as 3rd paper above 1118 Agricultural Assistant Grade-II were promoted to the cadre of Agricultural Assistant Grade-I. As per the final seniority list of Agricultural Assistant grade-I published vide 4th reference, only 238 Agricultural Assistant Grade-I are remaining in the department. In order to maintain the cadre strength of Agricultural Assistant Grade-I 699 vacancies existing are to be filled up by promoting senior most Agricultural Assistant Grade-II.

In the above circumstances, 699 Agricultural Assistant Grade-II are promoted to the cadre of Agricultural Assistant Grade-I on the scale of pay of Rs.13900-360-14980-400-16980-440-18740-500-21240-560-24040 as per the details shown in the annexure attached to this order with effect from the date mentioned against their names.

The incumbents promoted to the cadre of Agricultural Assistant Grade-I will continue to officiate in the same post in the same station for which the post held by them are temporarily be upgraded to that of Agricultural Assistant Grade-I.

The officers promoted will exercise option in terms of Rule 28 Part I KSR and as per the provisions laid down in G.O(P) 85/11/Fin dated 26.02.2011 and G.O(P) 143/11/Fin dated 30.03.2011.

The controlling officers should fix the pay of the incumbents in the promoted post of Agricultural Assistant Grade I and the fact should be recorded in the Service Book of the incumbents.
