Sub:—Amendment to Rule 86A Part I, KSRs—clarification—issued.

As per Rule 86, Part I, KSRs earned leave admissible for the first year of service is 1/22 of the period spent on duty. Before modification of this rule recasting of Earned Leave at the rate 1/11 for the first year is permissible only after an officer is confirmed in service. As this causes undue hardship the rule was modified to the extent that those who have competed 3 years service will become eligible for Earned Leave at the rate of 1/11 for the period spent on duty for the first year of service as admissible to a permanent employee. Now the Accountant General has sought clarification as to whether the intention of the Government is to allow the first year Earned Leave recast benefit to all the employees even after accruing the maximum limit of 300.

Government have examined the matter in detail and are pleased to clarify that as per Rule 78, Part I, KSRs an officer shall cease to earn leave when it amounts to 300 days with effect from 1-11-1998 and when a certain amount of leave is debited from the maximum leave, the officer will again start earning leave during the period of duty performed after the debit.

It is further clarified that the maximum amount of Earned Leave at the credit of officers at the time of their retirement, together with recast of Earned Leave under rule 86A, Part I, KSRs shall not exceed 300 days.
